

# Privacy Policy

## Introduction

This Privacy Policy describes what personal information we ( Bepom Inc - “We”) collect through our donor.app website (the “Site”), how we use and store it and helps you understand your rights in regard to your use of the Site.

Your personal information is collected and processed in accordance with the laws of the United States of California internationally accepted practices.

## Data Privacy

Any personal information that you disclose on the application/app clips is shared only with Bepom Inc, unless stated otherwise.

You agree that your name can be published on our website in connection with donations as a donor, if not stated that you wish to stay anonymous.

## Collecting Personal Information

When you access or use the Site, we can collect and store the following personal information:

- a) Personal information provided by you - name, last name, email address, phone number,
- b) Your donation history in the Site, the projects and areas where you have made a donation through the Site,
- c) Your Site usage session details, for example IP addresses, location information, the web pages you visited before coming to the Site,
- d) Correspondences that you had with us.

We do not store credit card information on our servers. We use SSL-encryption to protect data transmissions (such as your payment information and geolocation). We also offer HTTPS secure access to our website.

# Cookies

The Site uses cookies, which are small files stored on your computer's hard drive which are used to collect information related to your history of visiting the Site. This is usually done based on anonymous information. You may choose to refuse cookies but, if you do so, some of the functionality of the Site may no longer be available to you.

The Site uses Google Analytics and Google Maps services, which are provided by Google, Inc. These services collect information about your usage of the Site and store them on their servers in the United States.

We collect your personal information to ensure the performance of our website, to make your usage of the website convenient and secure. You agree that we can use your personal information solely for the following purposes:

- a) Normal operation of the website
